Subject: Recommendations for Majors Committees

The VSA Academics Committee has reached out to department chairs, program directors, and department interns, and has found that many departments and programs do not have a majors committee, or that the existing committee rarely meets and serves little purpose for the department or for the students who have declared or are considering declaring the major.

The Academics Committee noted that one challenge that majors committees face is a large degree of turnover from year to year. With most of their membership composed of third- or fourth-year students, graduation and JYA frequently leave little consistency in a majors committee from one year to the next.

In an effort to address that concern and make majors committees a more effective and sustainable asset for students at Vassar, the Academics Committee has compiled the following recommendations for majors committee structure and responsibilities. These recommendations were composed after consulting existing majors committees, and reflect work that many students have done or are engaged with currently. They are by no means exhaustive, and are not intended to take the place of valuable transitioning dialogues between chairs as majors committee leadership changes from year to year.

One of these recommendations is that majors committees be a voice for students with the department chair or program director, with the faculty members who teach in the department, and with the relevant administrators. Student concerns, questions, and ideas will be more effective and more representative if they are united and presented strategically, both in regular evaluation of the department and in response to unusual occurrences or circumstances. The student voice is vital to the health and improvement of academic life at Vassar, and should be solicited, united, and promoted by the majors committee.

Majors committees should also be a channel of communication from department chairs and program directors to students who are engaged with the department. At any time, but particularly in the current economic climate, it is imperative that students are well informed and provided with as much information as possible regarding their department. Majors committees can fulfill this responsibility by meeting regularly with their department chair or program director and disseminating information via email or in meetings, being available to majors and prospective majors for individual correspondence and meetings, and soliciting a response from students for faculty, department chairs, and administrators.

Furthermore, it is the belief of the Academics Committee that social life and academic communities need not be mutually exclusive at Vassar. With that view in mind, it is the recommendation of the Academics Committee that majors committees be a resource for integrating social components into academic relationships formed between majors, by organizing field trips, on-campus events, etc.

Finally, the Academics Committee recommends that majors committees preserve the excellence of their area of the curriculum and facilitate growth and enthusiasm through reaching out to prospective majors in an advisory capacity, displaying their pride on department merchandise (T-shirts, tote bags, water bottles, etc.), and hosting open houses or information sessions for students.

The Academics Committee recommends that majors committees are led by the department or program intern if an otherwise appointed chair does not exist. It is also our hope that information about the work and responsibilities of the committee will be passed from chair to chair each year. Other members of the majors committee can be voluntary or appointed as desired by the students in the department. The Academics Committee also encourages

majors committees to involve students from multiple classes to promote inclusion and ease the transition for committees from year to year.

Description of Event:

Based on the classic 80s film version of the board game, this production brings Clue to Vassar and turns Main Building into the Hill House mansion. Beginning on the steps outside of Main the audience will become a part of an interactive murder mystery throughout the hallowed parlors of our oldest building. As the action and audience move from room-to-room in this unique adventure, this production is sure to be an exciting, original and fun theatrical experience.

Benefit to Students:

By performing two shows each night of the run - the later one starting around 11pm - we are hoping that this production will both reach new audiences and provide a late night alternative for community members who want a different type of late night program. Most of the theater at Vassar happens between 8-10pm and it is viewed as an early-evening activity before finding something else to do later on. Our goal is, for this one weekend, to make theater a destination - to have it become the main event of one's evening. In alignment with the VSA's goal of providing late night alternatives to events rooted in music and dancing, this production was conceived to fill that void. Because of the popularity of the movie and the centrality of the performance space, we believe that a new population that wouldn't usually go see a play will turn out to see Clue because of the unique nature of the event. As someone heavily involved in theater at Vassar I think it's important to continue finding new venues in which to perform and new ways to deliver compelling theater to the Vassar student body, and I think this production will accomplish both goals.

He will be discussing how we can stimulate dialogue and reflection on the ways that culture, power, and history affect the experiences of globalization beyond today's ideological, disciplinary, and institutional barriers.

Benefit to Students:

Given Professor Grovogui's substantial and critical works on race and self-determination in Africa, rethinking international law and morality, and different concepts of human rights and human existence, his talk will benefit students of various majors such as Political Science, Economics, Philosophy, Africana studies, International Studies, Pre-law, Sociology, etc. His lecture is pertinent to the ever-growing human rights movement all over the world on legal, political, social as well as material grounds.

Serving on the admissions committee to the graduate Political Science Program at Johns Hopkins, prof. Grovogui would be very helpful in giving insights and advice to Vassar students who are applying (or planning to apply soon) to grad schools, particularly those who are interested in higher degrees in Political Science.

His lecture is especially beneficial to Vassar students and faculty members who share the same research/writing interests with his in the fields of Africa politics, international law, race, and human rights.

The Forum strongly believe that his visit to Vassar will bring great intellectual as well as social benefits to Vassar student body and learning environment.
